## OVERVIEW OF RELEVANT STATUTUES

## TERMS OF OFFICE OF ELECTED OFFICIALS

In 2000, the General Assembly enacted legislation which broadens the circumstances under which towns can establish four-year rather than two-year terms of office for local elected officials and specifies that this covers members of boards of selectmen. By law, towns can establish four-year terms by charter for chief elected officials and the members of the legislative body. Under the act, the terms may be changed by ordinance as well, although an ordinance does not supersede the town's charter concerning terms of office.

## Sec. 7-6. Eligibility to vote

At any town meeting other than a regular or special town election or at any meeting of any fire, sewer or school district or any other municipal subdivision of any town incorporated by any special act, any person who is an elector of such town may vote and any citizen of the United States

of the age of eighteen years or more who, jointly or severally, is liable to the town, district or subdivision for taxes assessed against him on an assessment of not less than one thousand dollars on the last-completed grand list of such town, district or subdivision, or who would be so liable if not entitled to an exemption under subdivision (17), (19), (22), (23), (25) or (26) of section 12-81, may vote, unless restricted by the provisions of any special act relating to such town, district or subdivision. (Note: Accordingly, towns do not have the authority to increase the $\$ 1,000$ threshold. Only the General Assembly may do so.)

## § 2-1. Charter Towns

Chapter 99 of the General Statutes allows a town or city to enact a charter. The process for enacting a new charter or charter revisions is described in more detail in Sections 7-188 through 7-192. Under Section 7-193, every charter must provide for a legislative body; a chief executive officer; and all municipal officers, departments, boards, commissions and agencies required by the General Statutes.

## § 2-2. Legislative Bodies

Although the selectmen in a statutory town are the executive authority and "superintend the concerns of the town," the legislative body of a statutory town is the town meeting [Sections 7-12 and 1-1(m)]. For a charter town, the legislative body may be: (1) a town meeting; (2) a representative town meeting; (3) a board of select-men, council, board of directors, board of aldermen or board of burgesses; or (4) a combination of a town meeting or representative town meeting and one of the bodies listed in Section (3) [Sec-tion 7-193(a)(1)]. When a combination, the body having the greater number of members shall have the power to adopt the annual budget and shall have such other powers as the charter prescribes, and the body having the lesser number of members shall have the power to adopt, amend and repeal ordinances, subject to any limitations imposed by the General Statutes or by the charter.

## § 2-3. Chief Executive Officers

In a statutory town, the first selectman is the chief executive officer (Section 7-12a). For a charter town, the chief executive officer may be: (1) the first selectman; (2) a chief administrative officer appointed by the board of selectmen; (3) a mayor elected by the electors of the municipality; (4) a warden elected by the electors of the borough; (5) a town, city or borough manager appointed by the board of selectmen, the council, the board of directors, the board of aldermen or the board of burgesses; or (6) a chief administrative officer appointed by the mayor [Section 7-193(a)(2)]. Any municipality having a manager as its chief executive officer may also have a mayor who shall be the presiding officer of its legislative body, the ceremonial head of such municipality, and have such other powers and duties as the charter prescribes.

## § 2-4. Officers, Departments, Boards, Commissions and Agencies Generally

In a statutory town, all the municipal officers, departments, boards, commissions and agencies are determined by the General Statutes or, if permitted under the General Statutes, by ordinance. For a charter town, every municipality shall have all municipal officers, departments, boards, commissions and agencies required by the General Statutes or by a charter. Each municipality may have any municipal officers, departments, boards, commissions and agencies which are specifically allowed by the General Statutes or which are necessary to carry out any municipal powers, duties or responsibilities under the General Statutes [Section 7-193(b)].

## § 2-5. Additional Powers in Charters

Towns or cities which adopt a charter under Chapter 99 may, in addition to those powers granted in the General Statutes, manage, regulate and control the municipality's finances and real and personal property; regulate and provide for the sale, conveyance, transfer and release of municipal property; and provide for the execution of contracts and evidences of indebtedness issued by the municipality.
